

#### **Designing the Blueprint**




Blueprint tells us how many items to write to each outcome included in course outline

Based on importance, amount of content (competencies) and how easily can write questions


Importance and easiness based on ratings

### Why You Should Take the Blueprint Survey

- We know there are outcomes that aren't super vital to the course
- If an outcome is rated as very unimportant, we won't write questions to it
  - Strand ratings can de-emphasize Strand 1
- Method is used for certification and certificate organizations
- O This is the easiest way to impact content without writing questions
  - The more participants we have, the more precise the blueprint is
  - We also monitor comment data for feedback before each workshop



#### WebXam Support and Training


WebXam support staff resolved **2,603 email** requests, phone calls, and trouble tickets. Nearly **25%** of all support requests were received in April and May.

Training materials were viewed **2,223 times** from July 2022 to June 2023. These professionaldevelopment offerings include the **WebXam Users Workshop, item-writing workshop training videos,** and **eLearning modules** for teachers and administrators.

#### **SMEs by the Numbers**

#### **Business, Finance and Marketing**

- **NO** pretesting available for Business, Finance, and Marketing courses for the 2023–2024 school year.
- All end-of-course Business, Finance, and Marketing tests are in **field testing** this school year (2023–24).
  - 95 items per test
  - Extra time may be needed
  - End-of-course testing window closes in **April.**
  - Scores will be available in early May.

# Pretesting

- Credits remain \$2 per test delivered and can be paid for with a Purchase Order or by Credit Card.
- Credits can be added to your administrative account for later assignment to teachers.
- Credits added to your administrative account cannot be used until they are assigned to teacher.
- New Pretests are available for Transportation Systems.



# **Testing Policy Overview**

- Students should take an a WebXam assessment as part of completion for each enrolled course with an aligned WebXam Assessment and may retake those assessments in subsequent academic years if needed.
- Within an academic year, students may retake an assessment after 30 days of remediation time (excluding field tests).
- Graduating seniors may retake field tests in the same year after the tests have been finalized.

### **Program Support in WebXam**

Starting this year, Students and teachers must be added to programs in WebXam in order to be uploaded, entered and to test.



# What is Program Support in WebXam?

- Administrators, Teachers, Assessors, Students and Tests are grouped together into programs. A user or test can be part of one or more programs.
- A special District Testing Coordinator role is able to manage all programs within or managed by a district or Career Center/JVSD. This role can be assigned to one or many administrators.
- Within a program, restrictions can optionally be placed on Administrators and Teachers allowing only Read Only or Activate Only permissions.



# Why Program Support in WebXam?

- Simplify Activation for Teachers
- Simplify User Management, particularly for District Testing Coordinators
- Improve End-Of-Year report delivery accuracy
- Allow role customization for districts with special requirements
- End the use of the "hierarchy" which was cumbersome and no longer useful in many cases



# **District Testing Coordinators**

- A new role in WebXam that allows preferably at least 1 and up to as many administrators as you need to be specified as District Testing Coordinators (DTCs).
- An administrator can be a DTC for multiple districts/JVSDs.
- DTCs can:

Add or remove other DTCs for their districts Administer all programs located in or reporting to their districts

Manage students and teachers not assigned to any programs located in their districts

### **Student Management**

- Students are no longer assigned to teachers, pathways and tests directly
- Instead, they are assigned to Programs
- Students can be removed from all Programs if they are no longer enrolled in any but may re-enroll in the future
- In this case, the student is only visible to DTCs based on the student's location.



### **Teacher and Administrator Management**

- Teachers and Administrators must be assigned to at least on program when created.
- Administrators can be added to the DTC group after they are created.
- Teachers and Administrators can be added or removed from Programs either from their List pages or from the Program page.



# Uploads

- Upload format is unchanged, however...
- The "Additional Tests" column is no longer used, and subject code in this field will be ignored.
- A matching program, based on the building IRN, Pathway and Teacher, must exist. An error will indicate if such a program does not exist.
- This will mostly impact FCS programs, which previously had the ability to add a single test to a student account.
- WebXam recommends the use of "Tags" to reduce the burden of this change



### Activation

- The second step in activation "Select the District or Career Center that owns this program" is removed.
- The pathway selection step is now the Program selection step
- The Test selection step only includes tests in the selected program. Test names can also be customized, more on this in a moment.
- The student selection step continues to include a way to select students based on Tags.

### **Program Restrictions**

- Teachers and Administrators may be assigned Restrictions at the program level.
- The two restrictions are "Activate Only" and "Read Only"
- The restrictions do not apply to DTCs



# **Program Restrictions – Activate Only**

- Cannot manage any accounts or run any reports. Can only activate tests and view their programs.
- Districts should ensure Uploads are complete, including Accommodations, before using this Restriction with Teachers
- Intended uses:
- Testing center personal who should not see student data
- 2. Districts that manage all student data and prefer teachers not have access to it



# **Program Restrictions – Read Only**

- Cannot activate tests.
- Can view Student, Teacher and Administrator (if allowed) Lists, but cannot edit student data.
- Can run all reports.
- Indented uses:
- 1. EMIS staff that are no involved in other parts of the testing process
- 2. Third-party vendors.



# **Program Test Name Customization**

- The Alternate names of WebXam Tests may be supplied for purpose of Activation.
- The custom name will appear in parentheses after the subject code and Subject name in the Test Selection step of Test Activation.
- Intended Uses:
- 1. Including the school-specific course name
- 2. Providing a hint to teachers about which students should be activated (e.g., "Juniors Only")




